

NCAA MEN'S FROZEN FOUR® TICKET GIVEAWAY
Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The NCAA Men's Frozen Four® Giveaway (the "Sweepstakes") starts on April 1, 2018 at 10:00 a.m. Eastern Time ("ET") and ends on April 30, 2018 at 11:59 p.m. ET ("Sweepstakes Period").

ELIGIBILITY: Sweepstakes is open to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older. Employees of the National Collegiate Athletic Association ("Sponsor"), Turner Broadcasting System, Inc., and each of their respective parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate families (spouse and parents, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter or win. HOW TO ENTER: During the Sweepstakes Period, visit <http://www.NCAA.com/FrozenFour> or FrozenFour.fancam.com and follow the instructions provided to complete and submit the online entry form to receive one (1) entry. All entries must be received by 11:59 p.m. ET on April 30, 2018 to be eligible. Entries generated by script, macro or other automated means and entries by any means which subvert the entry process are void. Limit one (1) entry per person and per email address throughout the Sweepstakes Period. All entries become the sole property of the Sponsor and will not be acknowledged or returned. Sponsor's clock is the official timekeeper of this Sweepstakes.

RANDOM DRAWING: On or about May 1, 2018, Sponsor will select one (1) potential winner in a random drawing from among all eligible entries received throughout the Sweepstakes Period. Odds of winning depend on the number of eligible entries received.

WINNER NOTIFICATION: On or about May 2, 2018, the potential winner will be notified by phone and/or e-mail. Potential winner may be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release after the date of issuance.
